In consideration of being permitted to attend and participate in this event and in recognition of NRIBR's reliance hereon, I agree to the terms and conditions set forth in this agreement ("Release").

Attendee assumes all risks and accepts sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that attendee may experience or incur in connection with attending the Northern Rhode Island Board of REALTORS® Annual Meeting and Installation of Officers and Directors. Attendee hereby releases, covenants not to sue, discharges, and holds harmless the Northern Rhode Island Board of REALTORS®, its employees, agents, and representatives, of and from any such claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto.

Specifically relating to the global COVID-19 pandemic, attendee acknowledges the highly contagious nature of COVID-19 and voluntarily assumes the risk of exposure or infection by attending the Northern Rhode Island Board of REALTORS® Annual Meeting and Installation of Officers and Directors, and that such exposure or infection may result in personal injury, illness, disability, and/or death to attendee. Accordingly, attendee understands and agrees that this release includes any claims based on the actions, omissions, or negligence of Northern Rhode Island Board of REALTORS®, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in the Northern Rhode Island Board of REALTORS® Annual Meeting and Installation of Officers and Directors.
