## **2024 SCHOLARSHIP APPLICATION & RULES**

(BOD approved 6/27/23)

- 1. The scholarship will be awarded on the basis of scholastic achievement, leadership ability, and need.
- 2. The candidate must:
  - a) Be a high school senior or have at least one (1) year of college remaining. Their primary residence should be OR they are attending school in Burrillville, Central Falls, Cumberland, Foster/Glocester, Lincoln, Pawtucket, North Smithfield, Scituate, Smithfield, or Woonsocket or be a child of a Northern Rhode Island Board of REALTORS® Member.
  - b) Be in need of financial assistance.
  - c) Be a full-time student for the fall and spring of 2023/2024.
- 3. Candidates nominated in prior years are eligible for re-nomination.

4. The application and all attachments (see the checklist on the application, page must be received at: Northern Rhode Island Board of REALTORS®, Inc.,12 Breakneck Hill Rd. Suite 100, Lincoln, RI 02865 **NO LATER THAN MARCH 31, 2024.** 

All forms must be typed. The application is available as a fillable PDF form on www.nribr.realtor. The transcript must be in a sealed school envelope. And you must attach a one-page letter of recommendation from student's major teacher or counselor.

5. At the discretion of the Scholarship Task Force, the top three candidates may submit to a personal interview.

6. All applicants will be notified in writing in April. The selected candidate will be notified in writing of the award, and the \$1,250 scholarship(s) is paid directly to the college or university at the start of the student's Spring semester. Verification of student's enrollment must be provided by the educational institution along with their instructions on remitting payment to be credited to the candidate's account balance and must provide a contact name and phone number in their students accounts department. - 7. In the event any selected candidate does not accept the scholarship awarded, the scholarship will be awarded to the next highest candidate in order. The award or balance thereof, shall be relinquished and credited back to the Northern Rhode Island Board of REALTORS®, Inc. Scholarship Fund, if any selected candidate accepts the scholarship and thereafter does not attend school or does not maintain reasonable attendance or grades.
- 8. Handwritten applications will not be accepted. Applications missing any of the documents on the checklist will not be accepted.
