



2024 GOOD NEIGHBOR AWARD GUIDELINES

1. Nominees must be a REALTOR® member of NRIBR in good standing and have either a Primary or Secondary Membership.
2. Our Good Neighbor Award recognizes a NRIBR REALTOR® who has made an extraordinary impact on their community, or on the national or world stage, through volunteer work. Activities are not limited to real estate or housing issues.
3. Nominees should have made a significant voluntary contribution of personal time, but contributions of money, materials, or other resources will be considered by the judges as well.
4. Nominees will be judged on level of personal contribution, impact of personal contribution, broadness of impact, and the project's suitability as a role model for other REALTORS®.
5. The award is intended to recognize individual contributions, not association- or company-wide efforts. However, if an individual can be singled out as instrumental to the success of a group effort, he or she is eligible. If the achievements of two people (such as a married couple or co-founders of an organization) absolutely cannot be separated, they can enter as a pair and their entry will be considered as one.
6. Some portion of the nominee's voluntary community work must have taken place between during the time period indicated, (January 2023 - February 2024) but judges will also consider ongoing efforts outside that time frame that demonstrate a depth of commitment.
7. Nominees should be able to document the results of their individual involvement through published reports and/or testimonials from the organization they served or the people they helped.
8. Nominations must be accompanied by a thoroughly completed entry form to be considered.
9. Winner must be willing to be interviewed, photographed, filmed, and featured in NRIBR marketing efforts.
10. NRIBR and its ROTY-Awards Task Force is not responsible for lost, stolen, or misdirected entries.
11. Winner will be notified by phone.
12. Winner is only eligible for award once in a 3-year period.
13. REALTORS® may nominate themselves or may be nominated by someone else, such as another NAR member, a state or local association, or the community organization they served.
14. Grant award is **\$1,000** and will only be issued to a 501(c)3 nonprofit organization.

Application must be received at our office by the deadline of February 28, 2024.

Winner will be announced by March 31, 2024.
