Per Article X, Section 2(a)(1) of our Bylaws, Dues shall not be prorated if an individual held a membership during the preceeding calendar year, and a Reinstatement Fee in lieu of Application Fee will apply. Reinstatement Fees for Associates are \$125. Reinstatement Fees for Principals are \$150. If you are applying as a New Principal/Office, the Application Fee is \$200, not \$100... The Board shall not process any applications whose dues payment is incorrect and/or lack the required documentation listed below the grid. 5. If you are transferring from another Board, please provide a letter of good standing from your previous Board.

6. If you are transferring from another Board, please provide your certificate on the 3-hour REALTOR Code of Ethics class & your 2-hour Fair Housing class certificate for 1/1/25 - 12/31/27.
